- OWNER AUTHORIZES PENNYBRIDGE MARINE EMPLOYEES TO OPERATE VESSELS FOR PURPOSE OF SEA TRIAL, TRANSPORT, OR WATER TEST.
- NO OUTSIDE CONTRACTORS ARE ALLOWED WITHOUT OWNERS PRESENT. ALL BOTTOM PAINT MUST BE PERFORMED BY PENNYBRIDGE MARINE EMPLOYEES.
- NO GENERATORS OR HEATERS ARE ALLOWED IN WINTER STORAGE YARD.
- ALL BALANCES MUST BE PAID IN FULL BY MARCH 1ST. NO BOATS WILL BE RE-LAUNCHED WITH UNPAID BALANCES.
- A 10% COMMISSION WILL BE CHARGED FOR ALL BOATS/TRAILERS SOLD THROUGH PENNYBRIDGE MARINE. A 5% COMMISSION WILL BE COLLECTED FOR ANY BOAT/TRAILER SOLD WITHOUT A CONTRACT WITH THE MARINA.
- AUTHORIZED SUB-CONTRACTORS MAY BE SUBJECT TO FACILITY FEES.
